



## **Advisory Board**

The Advisory Board of the National Women's Council is a group of well-diverse governing entities that help guide, direct and implement the activities, programs and events within their respective market areas. The Advisory Board is a two-year commitment. Each advisory board leadership team is comprised of officers, committee chairpersons and/or co-chairpersons.

### **Officer Positions include:**

President  
Executive Vice President  
Vice President

Officers are required to be paid corporate members of the National Women's Council to be eligible for leadership positions. However, anyone who regularly attends and participates at the advisory board level can be a member of one or more of the committees. Individual members may also volunteer to chair or co-chair a committee.

Each committee will collectively and creatively formulate events, projects, and campaigns that will support the Vision, Mission, and Goals of the National Women's Council. There is a committee for each area of focus (Economic Empowerment, International Rights, Political Equality, Women's Health, Workplace Equality) to ensure that all areas are being equally represented in the events, programs, and campaigns. Each committee will be lead by a committee chair. Committee members and committee chairs serve two-year term.

### **Committee Chairs and Committees Responsibilities**

- ✓ Committees shall meet on a regular basis as determined by the Committee.
- ✓ Committee Chairs shall report their activities to the Vice President.
- ✓ Committees shall be comprised of a minimum of three members based on a voluntary basis, and can include individuals from general membership.



- ✓ Committee Chairs shall serve a two-year term.
- ✓ Committee Chairs shall provide Committee updates at each scheduled Advisory Board meeting.
- ✓ Committee Chairs shall demonstrate leadership to carry out the purpose of their Committee.
- ✓ Committee Chairs shall be elected by the Committee members, and must be a voting member of the National Women's Council.
- ✓ Committee members shall serve a two-year term on a committee.

## **Committees**

### **Economic Empowerment**

Purpose: To identify and plan events, projects, and campaigns, that positively supports economic empowerment through education and increasing awareness. The events, programs, and campaigns that are produced by this committee will assist women to create a more progressive economic situation for themselves and their families.

### **International Rights**

Purpose: To identify and plan events, projects, and campaigns, that positively supports a variety of international rights for women. The Advisory Board is responsible for supporting events and campaigns that are of assistance to women worldwide.

### **Political Equality**

Purpose: To identify and plan events, projects, and campaigns, that positively promotes the progression of women in political positions. The events, programs, and campaigns that are produced by this committee will raise awareness on how women can get involved in all levels of government.



### **Women's Health**

Purpose: To raise awareness of important women's health issues through events, projects, and campaigns. Through education, the Women's Health committee aims to make positive and health changes among various women's communities.

### **Workplace Equality**

Purpose: The Workplace Equality committee is responsible for planning and implementing events, projects and campaigns that will be educational and powerful tools to women that will support obtaining workplace equality.

### **Community**

Purpose: To provide information about the council's internal and external activities in a consistent, continuous, and timely fashion. This committee is responsible for communicating information about events, meetings, campaigns, marketing outreach, and programs via web, letters, and newsletters. The community committee's is categorized in these areas:
